On behalf of everyone at Catholic Charities, we are excited to welcome all new members of our housing community and say hello again to our amazing residents. It has been awhile since we have reached out to you through our housing newsletter, and since then, our community has expanded with the merger of Catholic Charities and Spokane Housing Ventures! In 2022, we are seeking to reconnect with you and provide space to highlight the amazing things that are happening within this combined community each day. Here, is where you can stay informed of important onsite services and news about Catholic Charities.

In 2020, we began to talk about a merger with Spokane Housing Ventures (SHV). Catholic Housing Services of Eastern Washington (CHSEW) and SHV have coexisted for decades, both supporting human dignity through high-quality, affordable housing. While these two organizations have operated independently, they share a common mission. In January 2022, we successfully finalized the merger and Catholic Housing Ventures (CHV) was born. To our delight, this expansion will allow significant opportunities for us to better serve all of you. CHV will now own and operate 60 properties throughout eastern and central Washington providing over 2,500 affordable housing units, equipped with onsite resident support services throughout the State of Washington

At Catholic Charities, we believe that everyone deserves safe and affordable housing, coupled with the necessary tools to maintain their housing. Some of you may already participate in onsite support services through many of our properties, others can expect to be connected with resources like case management, personal health and wellness classes, substance abuse counseling and treatment, adult education and employment readiness, access to primary health care and more in the near future. CHV properties are unique and designed to support residents in multifaceted ways that foster opportunities for future success and help to ensure housing security.

Though, not all our properties will include onsite services, each resident will have an opportunity to utilize many of the existing service programs that Catholic Charities provides in the community. Through programs like Food for All, we ensure food security and provide access to healthy, sustainable and affordable food options for residents. Through Senior Services, senior residents can access assistance with light housework through our volunteer chore program and rides to medical appointments and the grocery store with the help of volunteer drivers. Residents can also utilize counseling and behavioral health services with trust that our licensed social workers, mental health counselors and marriage and family therapists are available in times of need.

We are grateful for your trust in carrying out this process, and your patience while we work hard to integrate wraparound support services at each of our properties. We welcome you and we thank you for being a part of the new Catholic Housing Ventures community. 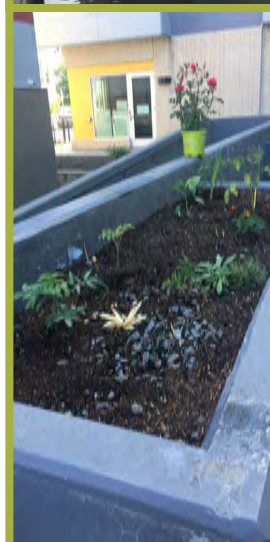
